RESPONSIBLE PURCHASING CHARTER

1. Purpose of the Charter

This Charter sets out Evea Agency's commitments with regard to responsible purchasing. It aims to embed the principles of sustainability, ethics, and social responsibility across all interactions with our suppliers and partners.

2.2. Ethics and Human Rights

- Collaborate exclusively with partners who comply with International Labour Organization (ILO) conventions, especially regarding child labor, forced labor, and decent working conditions.
- Promote diversity, equal opportunities, and inclusion within our supply chain.
- Apply a zero-tolerance policy toward corruption, discrimination, and conflicts of interest.
- Ensure respect for confidentiality and intellectual property rights in all contractual relationships.
